We are pleased to inform you that the **WORLD CUP – 2008**,women, **Olympic Qualification -**37th International Judo Tournament "Liberation" will be held on 26-27 January 2008 in Sofia.

All terms of the Tournament are according to the EJU regulations for WORLD CUP.

The women teams invited should consist of no more than 2 players in each weight category for the countries EJU -members and no more than 1 player in each weight category for the countries IJF -members.

All participating athletes must pay to the EJU a fee of 10 Euro per participant directly at the point of accreditation. The registration for all competitors and officials has to be done via **JUMAS ELECTRONIC SISTEM** /14.01.2008 final entry/.

Travel expenses to Sofia and return are on your account.

Accommodation - will be provided on your expenses in the:

1. Park-hotel Moskwa \*\*\* - 80 EUR per person per night – single room

- 70 EUR per person per night –double room

/Accommodation price includes breakfast B&B/.

Local transport (Airport-Hotel-Venue) is provided by the Bulgarian Judo Federation /15 min from Airport to the Hotel/.

Participating Country: 2 male referees plus 1 female referee

Non-Participating Country: 1 referee

#### 6. Competition system

The events will be organized in accordance with the Rules and sports code of the IJF, in KO system with double repechages.

#### 7. Doping control

The Gold Medal Winner and another Drawn Medallist from the rest (**TWO** tests per **WEIGHT CATEGORY** contested)

#### 8. Entries

- a) Numerical Entry National Federations are requested to inform the Bulgarian Judo Federation as to whether they will participate in the Tournament or not by prescribed Numerical Entry Form not later than 10th of December 2007.
- **b)** Nominal Entry National Federations are requested to send the Final entry Form not later than 14th of January 2008. Please note that the Nominal Entry forms are for organisational purposes. Registration has to be done in Jumas (see point 12 for further details)

Remarks - Please make sure that your team will arrive before 18.00 h, Friday, 25 of January 2008. No additional or any change of entries will be accepted after 18.00 h.

#### 9. Liability

Neither the organizers of the event, nor the Bulgarian Judo Federation will be liable or responsible for any personal injury nor for any loss or damage to your property arising out of your participation and traveling in connection with this Tournament.

#### 10. Advertisement

Please observe the regulations of **EJU** as advertisement on the judogi is concerned. Please note that during the Tournament no back numbers on the judogi are allowed unless specified by the organizer. Back numbers of previous tournaments must be removed from the judogi.

#### 11. Judogi

Please not, that according to the decision of the DC of EJU **blue and white** judogi will be obligatory in all EJU A-tournaments and each competitor must have her name on the back side of the judogi. The judogis will be given upon arrival to the registration and control of judogi for sewing the back numbers.

#### 12. EJU Participation Fee

All Federations must pay to the EJU a fee of 10 Euro per participant.

#### 13. Registration

The registration for all competitors and officials has to be done via the **JUMAS ELECTRONIC SISTEM**. The system closes the registration for this event on the **14th** of **January 2008**.
