2008 SENIOR FEMALE WRESTLING WORLD CHAMPIONSHIP 11-13 October, 2008 Tokyo, JAPAN

1. GENERAL INFORMATION

- 1.1 FILA confers the Japan Wrestling Federation with the organization of the 2008 Senior World Championship in Female Wrestling.
- 1.2 The Championship will take place according to the FILA Rules.
- 1.3 The Championship will be prepared and organized by an "Organizing Committee" which is under the aegis of the Japan Wrestling Federation.

2. INFORMATION, INVITATIONS AND INTERNET

2.1 The Japan Wrestling Federation is responsible for sending the entry forms which are needed for obtaining visas at the latest five months before the Championship. Regular information bulletins containing reminders of important information will also be sent up. An internet site with a link on the FILA site will be set up. This site will be kept up to date.

3. PARTICIPATION

- 3.1 All National Federations affiliated to the FILA can participate in the Championship as long as they have fulfilled all their financial obligations to the FILA according to the Constitution. The same applies to the Organizing Committee for accreditation rights.
- 3.2 Each National Federation can enter a maximum of one wrestler per weight category.
- 3.3 Each wrestler must have a valid FILA license for the year and have a valid personal passport.
- 3.4 Each competitor must be of the appropriate age for the competition according to the Wrestling Rules. Age and nationality will be checked using the passport at the weigh-in.
- 3.5 Preliminary entries for all the wrestlers and the accompanying delegation members must be sent to FILA and to the Japan Wrestling Federation before July 31, 2008.
- 3.6 Entries by name must be sent to FILA and to the Japan Wrestling Federation before August 31, 2008.
- 3.7 The final list of wrestlers entered for the Championship must be presented to the competition secretariat before midday (12:00) on the day of the official weigh-in.
- 3.8 The above conditions must be respected by National Federations wishing to attend the Championship in order for accommodation to be booked according to the Regulations.
- 3.9 The structure of the official delegation is laid down by the FILA as follows:

The number of referees stipulated above is the minimum. The participating Federations can present one referees per mat. All the referees who are authorized to work will be accredited with the same conditions as the participants.

4. TECHNICAL CONDITIONS

- 4.1 The competition will take place according to the FILA Regulations.
- 4.2 The competition will take place with the weight categories laid down in the wrestling rules for the age category for that competition. No tolerance is allowed.
- 4.3 The competition will take place on FILA approved mats.
- 4.4 Each wrestler must undergo a medical examination in his country three days before leaving for the competition. The results of this examination will be noted in his license book.
- 4.5 Each wrestler must undergo a medical check within the hour preceding the official weigh-in.
- 4.6 The Organizing Committee is responsible for the first aid costs during the competition. The annual FILA stamp covers medical assistance to the wrestler in the event of an accident. If the person insured wishes to have a medical examination or receives treatment which is not linked to the accident which happened during the competition, either she or her National Federation must bear the cost of this examination or treatment. These costs cannot be reimbursed by the insurance company.
- 4.7 The positive points obtained during the individual competition will determine the team classification. The wrestlers placed 1st to 10th will receive between ten and one point. If there is a draw of positive points for the final classification, the gold, silver and bronze medals will be taken into consideration in order to determine the winner.
- 4.8 The Japan Wrestling Federation will organize, under the FILA authority, anti-doping tests as laid down in the FILA Regulations. The laboratory used to analyze these tests must be IOC approved. The procedure for undertaking the tests and transporting the samples to the laboratory is laid down in the anti-doping code of IOC and the WADA. Without being informed in advance, the FILA will not accept any foreign interference in the FILA Anti-Doping Commission, the only body which may undertake anti-doping tests and samples during the Championship.

5. OFFICIALS

- 5.1 Only the FILA referees of the category specified in the Championships Regulation may work in the competition.
- 5.2 Each referee must present his/her valid license for the year.
- 5.3 A FILA referees course will be organized according to the dates and times indicated in the Championship Program.
- 5.4 Referees must wear the official FILA uniform.

6. PRIZE

6.1 The Organizing Committee will give individual prizes for each weight category:

1st place Gold Medal, Certificate

2nd placeSilver Medal, Certificate

3rd place Bronze Medal, Certificate

5th to 10th place Certificates

Special prizes may also be awarded to wrestlers.

6.2 The first three teams receive a cup.

7. OFFICIAL CEREMONIES

- 7.1 Each participating team must be present at the opening ceremony of the Championship according to the Organizing Committee's instructions.
- 7.2 The national or Olympic flags of the countries whose wrestlers and teams placed $1^{st} 3^{rd}$ will be hoisted once the medals have been awarded.
- 7.3 The national or Olympic anthem will be played for each individual and team champion.
- 7.4 The organizer will provide the flags and national anthems. However, each participating team must bring his flag (100cm X 150cm) and a tape or CD of his national or Olympic anthem.

8. FINANCIAL CONDITIONS

- 8.1 According to the FILA Regulations, participation costs for all the delegations will be calculated per night, to a maximum of two days before and one day after the Championship, on the basis of SFR 130 per person per night.
- 8.2 The team leaders must fulfill the Organizing Committee's financial obligations as soon as they arrive.
- 8.3 The delegation leader will settle his team's participation costs in full. No accreditation will take place without the participation costs being paid.

- 8.4 Delegations with more members than allowed in the article 3.9 of this regulation, as well as those delegations staying longer than the period allowed in the article 8.1 above must pay SFR 200 per person per night.
- 8.5 The FILA Commission members who are called to meet during the Championship will be accredited under the same financial conditions as the participating teams.
- 8.6 In strict conformity with FILA instructions, each team which has been entered for the Championship but which does not turn up or turns up with fewer wrestlers or accompanying members than originally planned will have to pay the Organizing Committee the hotel costs for all the individuals previously entered. This requirement will be put into application by issuing the settled invoices.
- 8.7 Team leaders will be responsible for any damage incurred by members of their delegations during the stay.

9. ACCOMMODATON, FOOD AND TRANSPORT

- 9.1 Hotels for the teams and referees:
 - Keio Plaza Hotel Tokyo
- 9.2 The Organizing Committee will provide transport for the teams from their arrival at the closest international airport of from the local railway station.
- 9.3 All the delegations must arrive a maximum of 48 hours before the competition and leave at the latest at noon on the day after the end of the Championship.
- 9.4 The competitors may stay from the beginning to the end of the Championship according to the financial conditions laid down in point 8.1 above.
- 9.5 Basically accommodation for all the competitors is provided in twin rooms with full sanitation.
- 9.6 Meals corresponding to a calorific value of the FILA Rules (5,000 cal/day) will be served to those accredited in the hotels where they are staying.
- 9.7 Shuttles will be organized to transport those accredited form the hotels to the competition hall or to the training areas.
- 9.8 Saunas will be made available in the hotels of training areas.
- 9.9 The Organizing Committee is not responsible for people who are not on the list of entries by name, nor for people entered over and above the number allowed for in the Regulations unless this is agreed beforehand.

10. JOUNALISTS - TELEVISION - VIDEO RECORDING

10.1 Accreditation forms will be sent to each National Federation. These forms must be returned to the FILA and the Japan Wrestling Federation by e-mail and fax not later than August 31, 2008. One ID photo (4.5 x 3.5 cm) has to be sent by e-mail and post with the full name and country.

- 10.2 Foreign Broadcasting companies wishing to use the international feed for the Championship must inform the FILA and also inform the Japan Wrestling Federation before August 5, 2008. Applications after this date will not be accepted.
- 10.3 Journalists are responsible for their own accommodation. However, hotels can be suggested by the Japan Wrestling Federation if asked for in advance and in writing.
- 10.4 A Press Center comprising all the necessary equipment will be made available to journalists the day before and one day after the Championship.
- 10.5 Countries must make their request for video cameras to be used at the Championship at lease one month before the Championship. A specific invoice will be issued to each country concerned.
- 10.6 Video recordings for educational purposes will be made following a contractual agreement with the FILA and with accreditation by the organizers. No digital video cameras will be accepted in the competition hall without these requirements being met.
- 10.7 Television companies which are not members of the EBU must sign a contract with the FILA, be accredited and have paid the amount set out in the financial Regulations in order to receive an unilateral position or obtain images from the recording from the host broadcaster.

11. ENTRIES

11.1 In order to be considered as valid, entries must be sent to the FILA and the Japan Wrestling Federation on official forms by e-mail and fax within the time limit set out below:

A. Preliminary entries: July 31, 2008

B. Entries by name: August 31, 2008

* one ID photo (4.5 x 3.5 cm) for accreditation by e-mail and post to the Japan Wrestling Federation only // note on the back : country/name/weight category

C. Final entries: at noon on the day of official weigh-in

12. MISCELLANEOUS

12.1 Competitors or Journalists who require VISA to come to the Championship must contact the Embassy or Consulate of Japan in their country/region of residence.

VISA forms sent to each National Federation with accreditation forms must be returned to the Japan Wrestling Federation. According to the requirement of the Foreign Ministry of Japan to issue VISA, the members who wish to participate in the Championship will have to fill in the accreditation form and the VISA form in block capital letters and return them to the Japan Wrestling Federation by e-mail and fax not later than August 1, 2008. When VISA supporting documents are prepared and sent to the respective National Federations by the Japan

Wrestling Federation, the applicant must present himself/herself with the documents, valid passport and a photo to the Embassy/Consulate of Japan in his/her country and fill in the required VISA application form. A VISA will be issued as soon as Japan Embassy/Consulate of Japan receives the approval from the Foreign Ministry of Japan.
