## 4<sup>th</sup> Individual Trophy "Comune di Barcis"

### General

"SPORTING SUMO" International event entered in the European Sumo Federation calendar and in , Italian federation FIJKAM (Federazione Italiana Judo Lotta Karate Arti Marziali) calendar.

The event will be held in Barcis (PN) at sport facilities area "Campi sportivi" on **July 15<sup>th</sup> 2012** starting at 14.00

#### PARTICIPATION RULE:

The entry is open to the Athletes of the Federations members of the European Sumo Union (E.S.U.) and International Federation of Sumo (I.F.S.).

The entry form with the confirmation of the participation shall reach the organizers by e-mail at [asd.sportbarcis@live.it](mailto:asd.sportbarcis@live.it), at latest on July 2<sup>nd</sup> 2012. After this date, the Organisers shall refuse possible late entries.

JURY AND COMPLAINS: the competition will be managed by International Judges together with National Officials. The International Regulation will be followed and no complaint against the Jury will be accepted. The judges uniform is the one conforming to the International regulations (except to the possibility of wearing white shirt with short sleeves).

OPENING CEREMONY: all athletes taking part in the event have to be present to the Opening Ceremony and shall wear their competition uniform (Mawashi).

#### EXPENSES IN CHARGE TO ORGANISERS:

Participating teams (athletes, one coach and one referee) will be offered:

- Welcome and transport from and to the airports Marco Polo in Venice and Trieste International airport or from the Railway Station in Pordenone.
- Lunch and dinner on July 15<sup>th</sup> 2012
- B&B on July 14<sup>th</sup> and 15<sup>th</sup> 2012

#### EXPENSES IN CHARGE TO PARTICIPANTS:

- Travel expenses to the airports and railways station as from above mentioned.
- Entry fee of **Euro 15,00** (euro fifteen) for each athlete, valid for both events, to be paid during the weighing

WEIGHING: Saturday July 14<sup>th</sup> 2012 from 19:00 to 20:00 and Saturday July 15<sup>th</sup> 2012, from 10:00 to 11:00. A tolerance of kg.1,00 is permitted.

## **Particular Regulation**

Mixed teams competition: 2 men (kg -85 and Open) and 1 woman (Open).

RUNNING OF THE EVENT: tournament will be run with double repechage system, maximum time for fight 3 minutes. There will not be ex equo, a contest to define the 3<sup>rd</sup> and 4<sup>th</sup> position will be held.

PRIZES: Trophy and money prizes to first 3 teams:

1<sup>st</sup> Team € 500

2<sup>nd</sup> Team € 300

3<sup>rd</sup> Team € 100

## **Particular Regulation**

RUNNING OF THE EVENT: the tournament will be run with double repechage system, maximum time for fight 3 minutes. There will not be ex equo, a contest to define the 3<sup>rd</sup> and 4<sup>th</sup> position will be held.

WEIGHT CATEGORIES: Competition with 5 weight categories(3 men and 2 women ones)

Men:           **-85kg,           -115kg,           +115kg.**

Women:       **-65kg,           +65kg**

No age classes are foreseen.

PRIZES to the first 3 athletes in each category
